With a quorum present, the regular meeting of the San Marcos City Council was called to order by Mayor Daniel Guerrero at 5:02 p.m. on Tuesday, September 2, 2014 in the City Council Chambers, 630 East Hopkins, San Marcos, Texas 78666.
