Good morning Melissa,

I hope you are doing well! I left you a voicemail on Friday to discuss your request, but I haven't heard back from you. I know you are a busy lady. I took this over for Ms. Roberts on Friday.

I spoke with our Real Estate Acquisition Administrator and Rodney Cobb on Friday to see if we had a listing of all of our properties somewhere with the total acreage. I have been informed that the parks listing that Ms. Roberts has already provided you is the most current document showing our total acreage for parks and open space. This includes neighborhood parks. The number listed on the website is incorrect and needs to be updated. I've let the appropriate folks know about that. So our total acreage of park land and open space is 2002, more or less.

We do not have a document that has the total acreage for all city owned properties at this time. Staff is working on compiling that information, but it's not complete. So in response to your Open Records Request we do not have any responsive documents to be able to provide the total amount of acreage of all properties owned by the City of San Marcos.

Hi Melissa,

How strange that you didn't receive my message. It was last Friday between 2 and 3 when I called. Unfortunately, I cannot provide a timeline on this project right now. This work will take months to complete and we don't have the Staff to devote solely to this. If you want to get a general idea you can always do a property search on Hays Central Appraisal District's website for the City of San Marcos. There will be hundreds of properties listed. Not all of them are COSM. Some of them are the Housing Authority and will be pulled into the search.

The properties will range anywhere from parcels like Purgatory Park and as small as a piece of right-of-way.

I will keep you in the loop when Staff gets this completed, but I don't expect that it will be any time soon.
