





### RESEARCH REPORT ON RUBEN BECERRA

- Five tickets were found issued to Becerra. In all five instances, he failed to appear and a warrant (or additional citation) was issued. The five tickets were for:
  - o Failure to maintain financial responsibility (driving without insurance)
  - Two citations for failing to restrain a dog
  - Two citations for failing to exercise control over an animal to prevent it from becoming public nuisance
- Five lawsuit were found involving Becerra:
  - o Small claims lawsuit filed in JP court in 2010
  - o Delinquent taxes filed in Comal County district court in 2009
  - Delinquent taxes filed in Hays County district court in 2012
  - o Failure to pay under contract terms filed in Nueces County Court at Law in 1999
  - Failure to pay under contract terms filed in Nueces County Court at Law in 1999
- Becerra failed to pay property taxes on time on at least nine separate occasions. The most recent instance was that Becerra paid taxes for 2017 on July 30, 2018.
- In 2012, Becerra defaulted on his home loan. An appointment of substitute trustee was filed with the Hays County Clerk. This is an initial step in foreclosing on a property and selling it.
- One bankruptcy was found involving Becerra. The Chapter 13 bankruptcy was filed in August 2004. At the time of the filing, Becerra reported owing between \$100,001 and \$500,000 in debt.




