6. **VR-21-06** (Vantage Stormwater Detention and Drainage Variance - 3625 SH 123). Hold a public hearing and consider a request by Chris Weigand on behalf of Vantage at San Marcos, LLC for the following:
 - (a) a variance to Section 3.9.1.1.F to allow runoff greater than pre-construction conditions by 34% for the 2-year storm and 15% for the 100-year storm,

(b) a variance to Section 3.9.1.1.B.3 to allow an increase in the off-site water surface elevation by 0.05 to 0.15 feet without a dedicated easement. (G.Schwarz).
